Structure, Contents, Learning Outcomes

The amount of credits covered by the program is 240 credits, including:

- ➤ 191 ECTS obligatory components (10 ECTS Legal Practice within),
- ➤ 49 ECTS elective component (Practical Component of the Specialty 32 ECTS; Criminal Law Component 36 ECTS; Civil Law Component 40 ECTS; Public Law Component 49 ECTS; International Law Component 12 ECTS; Foreign Language Component 10 ECTS.

Information Technology	5	The course aims to teach students computer technologies and office programs.
Academic writing	5	The course aims to teach students how to plan / execute official documents / scientific papers according to the standards and also to develop basic writing skills required for the legal profession.
Constitutional Law	5	The course aims to provide students with an adequate understanding of constitutional law and to teach the fundamental principles of the constitution.
Basics of law	5	The course aims to get students acquainted with the basics of state and law, basic principles, categories and institutes of law.

English for Specific Purposes – Law (B1)	5	During the course students will work with legal documentation in English (B1 level) of appropriate difficulty in subfields of criminal law, civil law, constitutional law and develop skills of interpretation and translation in Georgian.
English for Specific Purposes – Law (B1+)	5	The course aims to improve and refine students' English language proficiency (reading, writing, listening, speaking) (B1+ level). The course aims to prepare student for the legal English exam - TOLES Intermediate Exam.
English for Specific Purposes – Law (B2)	5	The course aims to improve and refine students' English language proficiency (reading, writing, listening, speaking) at B2 level. The course aims to prepare student for the legal English exam - TOLES Advanced Exam.

Students will gain the proficiency (listening, reading, speaking, writing) in these languages and acquire knowledge of aspects of the language system (grammar, vocabulary, phonetics, spelling), learn terminology in this language and get acquainted with the socio-culture of business relations in the targeted language area.

Legal Ethics	3	The aim of the course is to teach student ethical standards of the legal profession.
Legal Psychology	3	The aim of the course is to get the student acquainted with the main empirical and theoretical content of general psychology and based on that teach legal psychology.
Communication Psychology	3	The aim of the course is to make the students acquainted with basic terms of "psychology of communication" mainly in the social-psychological context. The course focuses on developing awareness of communication techniques and more accurate perception of self and others
Debate and Public Speaking Skills for Lawyers	3	The aim of the course is to provide students with an opportunity to learn the basic principles and features of debates and public speaking techniques.
Street Law	4	Street Law course is intended to provide students with the ability to understand government, individual rights, laws and legal disputes. This is accomplished through case studies, mock trials, legal research, and other methods. Students will gain a practical understanding of law and the legal system, and how it relates to their everyday lives.
International Moot Court	3	Students are eligible to participate in this course by application and competitive selection only. This course offers

		students the opportunity to work on complex and cutting- edge questions of international law through preparation for, and participation in, a distinguished international law moot competition. In the process, students will develop and refine advanced legal research and advocacy skills. The moot competitions will usually include the prestigious international law moots, including the International Arbitration Moot. Students will be expected to attend induction and moot training sessions, and then to undertake intensive research in international law, prepare written submissions and develop oral submissions which are then refined through mooting practice.

Election Law	3	The aim of the course is to study electoral principles, the basics of electoral systems, electoral processes and forms of direct democracy in Georgia and in developed foreign countries.

History of Legal Thought	3	The aim of the course is to provide students with an adequate understanding of the major tendencies of legal thought development from the ancient times to the present.
Healthcare Law	3	The aim of the course is to get students acquainted with the state's approaches to ensuring basic health rights.
Constitutional Principles of State Organization of European Countries	4	The aim of the course is to provide students with an in-depth understanding and teach them the principles and process of organization and exercising of state governance in European countries.
Clerical Law	3	The aim of the course is to get students acquainted with the legal and ethical standards of public service work, protection of which is the duty of each servant.

Repetitorium in Administrative Law	5	The aim of the course is to deepen student's knowledge about differentiation between the legal forms of administrative body's activities and about their procedural legal matters.
Finance Law	3	The aim of the course is to get students acquainted with the main issues of financial legal regulation, the budget process and the main goals and means of financial activities.
Banking Law	3	The purpose of the course is to give the students extensive knowledge in the area of banking law; teach them the essence and structure of banking law.
Modern Trends of Governance in Post Socialist Countries	3	The aim of the course is to teach and provide students with an adequate general understanding of the modern tendencies of governance in the post socialist (Central and Eastern European) countries.

Maritime Law	3	The aim of the course is to teach the student the basics, principles and main directions of international maritime law.
Diplomatic and Consular Law	3	The aim of the course is to provide students with an understanding of important issues in diplomatic and consular law.
International Refugee Law	3	The aim of the course is to provide students with knowledge about the basic principles of refugee law, its development history, and refugee status.
Law of the Air	3	The course in Public International Air Law examines the relevant principles and rules of public international law that affect the use of airspace and aeronautics.

Learning Outcomes

- Graduate has extensive knowledge of theories, basic concepts of national law, in particular the methods of law, the history of Georgian law, public, private, criminal, international law, and the established directions of judicial practice;
- Can identify legal problems, seek normative grounds for their resolution, interpret norms and subsume factual circumstances, draft legal documents (draft of normative act, contract, complaint, suit, etc.); participate in the law-making and law-enforcement process;
- Has the necessary practical skills (individual and team work, multitasking, working under pressure, instant reaction in critical situation and other skills);
- Has the skills of making communications of different nature with interested parties about legal matters, both verbally and in writing;
- Performs professional activities adhering to the ethical considerations, understands their importance and strives to implement them in public relations.

Evaluation System

The maximum assessment point of each course is 100. The passing grade for awarding credits is 51 points and this grade shall consist of the points of the midterm evaluation(s) and the points of the final assessment. The student should pass the minimal competence level set for midterm evaluation and final assessment. The minimal competence level of the midterm/final evaluation is defined by syllabi.

The grading system shall allow:

- a) Five positive grades:
- (A) Excellent –91-100 points;
- (B) Very good –81-90 points of maximum grade;
- (C) Good 71-80 points of maximum grade;
- (D) Satisfactory 61-70 points of maximum grade;

- (E) Acceptable –51-60 points of maximum grade;
- b) Two types of negative grades:
- (FX) Fail -41-50 points of maximum grade, meaning that a student requires some more work before passing and is given a chance to sit an additional examination after independent work;
- (F) Fail –40 points and less of maximum grade, meaning that the work of a student is not acceptable and he/she has to study the subject a new.

The final grade is composed of the summation of midterm evaluation(s) and the final evaluation.
